WHO WE ARE

This Privacy Policy is issued on behalf of Bento Nouveau Inc and we operate the bentosushi.com website. Bento Nouveau Inc is part of the Snowfox Group so when we mention "we", "us" or "our" in this policy, we are referring to the relevant company in the Snowfox Group responsible for processing your data.

This Privacy Policy explains how personal information is collected, used and disclosed by us. We are committed to collecting, using and disclosing personal information responsibly and in accordance with this Privacy Policy, and the Personal Information Protection and Electronic Documents Act ("PIPEDA").

For the purposes of this Privacy Policy, the term "personal information" means any information that is defined to be personal information under applicable privacy laws. Usually, this refers to any information about an identifiable individual or any information that can be used to identify an individual.

If you do not consent to the collection, use and disclosure of your personal information in accordance with this Privacy Policy, do not provide us with any personal information. It is important to note that some of our products and services can only be provided if we receive appropriate and required personal information. Consequently, should you choose not to provide us with the required personal information, we may be unable to offer these products and services to you.

WHY WE COLLECT PERSONAL INFORMATION

We collect personal information for various reasons. Usually, it relates to improving our website and your experience interacting with the site. We may also collect personal information for any of the following purposes:

- To allow you to participate in a contest;
- To receive and process your comments about the business, and for other business activities;
- To provide products and/or services to users and/or access to the website;
- To comply with our legal obligations and regulatory requirements;
- To provide information to anyone working with or for us as needed for the provision of our products and services;
- To develop and manage our business and operations, including but not limited to for billing, accounting and debt collection services relating to our products and services;
- To establish, maintain and manage our relationships with users of the website;

- To detect and protect us and third parties from error, negligence, breach of contract, fraud, theft or other illegal activity, and which may include sharing personal information with our insurers, and to otherwise communicate with our insurers;
- To review potential fraud and as required in the course of activities to achieve credit risk reduction;
- To generate analytics; and
- For any other purpose for which we have your consent.

WHAT PERSONAL INFORMATION DO WE COLLECT?

Our website collects information in several ways.

Personally identifiable information

Some personal information is gathered when you register for a competition. During registration, our website asks you for your name, telephone number, and email address. To register, you must provide all this information.

In addition, we keep copies of information you submit when you send email feedback to us, ask a technical question, or report a problem. If you contact us in writing through our website, we may keep a record of that correspondence.

We do not intend to collect any sensitive personal information on our website and therefore you should not include any sensitive personal information (e.g., data relating to your health, finances, sexual orientation, religion, racial or ethnic origin, political opinions) on your profile or otherwise on our website.

Usage Data

Usage Data is collected automatically when you access our website.

Each time a visitor comes to the website, our web server may collect and log certain information in access logs. Such access logs may be kept for a reasonable period of time. Access logs may include Usage Data, such as your device's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our website that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the website by or through a mobile device, We may collect certain information automatically, including, but not limited to, the type of mobile device you use, your mobile device unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

We may also collect information that your browser sends whenever you visit our website or when you access the website by or through a mobile device.

Tracking technologies and cookies

We use cookies and similar tracking technologies to track the activity on our website and store certain information. Tracking technologies used are beacons, tags, and scripts to collect and track information and to improve and analyze our website. Anonymous data

We may collect anonymous information as you navigate the website. We may use anonymous information to operate and improve the website. We may also use anonymous information to track what visitors to the website are looking at most frequently so we can recognize and deliver more of the desired features, products, and services.

CONSENT

Wherever possible, we seek a person's consent before we collect their personal information. The form of consent may vary depending on the circumstances and the type of information being requested. Consent

can be express or implied, and can be provided directly by the individual or by an authorized representative.

By accessing our website or providing your personal information to us, you agree that we may collect, use and disclose your personal information in accordance with this Privacy Policy and as otherwise permitted or required by law, and that we may access, process and store your personal information in Canada or another jurisdiction.

When we receive personal information from you for the purposes of providing you with our products or services, or for other uses identified herein, you are providing us with consent as follows:

- to allow us to deal with that personal information in a reasonable manner;
- to allow us to provide your personal information to third parties we engage to provide or support the website:
- to allow us to use and store your personal information for the purpose of providing you with the products and services you purchase from us and to utilize the website; and
- to allow us to transfer your personal information outside of Canada (whereby your personal information will be treated in accordance with applicable foreign laws) for the purpose of storage and use of your personal information by us.

If you need to provide us with personal information about other individuals, you represent and warrant to us that, where required by law and prior to your disclosure to us, you will obtain the consent of each individual to the collection, use and disclosure by us for the specific purpose(s) that the disclosure is made by you.

Providing us with your personal information is always your choice.

If we sell our organization or merge with another party, your consent will be implied to transfer your information to our successor for the same purposes as set out in this Privacy Policy.

We will not use your personal information without your consent unless it is either:

- for the same purpose for which the information was originally collected or compiled;
- consistent with that purpose; or
- for a purpose that may be disclosed under legal or regulatory purposes. For example, under certain exceptional circumstance we may have a legal duty or right to disclose personal information without your knowledge or consent. Various government agencies such as the Canada Revenue Agency, Human Rights Commission, Ontario Ministry of Finance; Ontario Ministry of Labour, and law enforcement, have the authority to review our files and interview our staff when deemed necessary. These agencies have their own strict privacy obligations.

Withdrawing consent

You may, at any time, withdraw your consent to our collection, use and disclosure of your personal information, subject to reasonable notice and any legal and/or contractual restrictions.

Should you choose to withdraw your consent, we may be unable to provide, or continue to provide, the website or some of our products and/or services that can only be provided if we receive appropriate and required personal information.

LIMITED COLLECTION, USE AND DISCLOSURE

We will only collect such information that is deemed necessary to meet the purpose for which such personal information is collected.

We will only use your personal information in accordance with this Privacy Policy. If in the course of managing our business operations, we share your personal information with professional advisors, franchisees, suppliers, any such entities shall be required to comply with our privacy guidelines that impose obligations at least commensurate with this Privacy Policy.

We do not sell or disclose personal information to third parties, other than in compliance with this Privacy Policy and as required to satisfy any law, regulation, legal request, to protect our business interests, and to co-operate with any law enforcement investigation or on matters concerning public policy and safety.

TRANSFER OF PERSONAL INFORMATION

Your information, including personal information, is processed at our operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction.

Your submission of your personal information represents your agreement to that transfer.

We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your personal information will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

SAFEGUARDING PERSONAL INFORMATION

We have implemented security policies, rules and technical measures to protect the personal information that we have under our control from unauthorized access, improper use or disclosure, unauthorized modification, unlawful destruction or accidental loss.

All our employees and service providers, who have access to, and are associated with the processing of personal information, are obliged to respect the confidentiality of our visitors' personal information. We ensure that your personal information will not be disclosed to Government institutions and authorities except if required by law, regulation or by a court of competent jurisdiction or a duly authorized administrative or legislative authority.

Also remember to close your browser window when you have finished your work. This is to ensure that others cannot access your personal or business information if you share a computer with someone else or are using a computer in a public place.

ACCURACY

While we collect the personal information that you supply, we do so with the understanding that any such information is accurate.
